Key Changes for PCA 2019

- Existing sections removed – D, E & F
- New sections – A6, D, E and Schedules being developed
- New Term-Acceptable Plumbing Manuals
- Many other small changes

Change to Categories of Work

- Category 2B – Low risk work
- A form 80 not required when servicing an On-Site Wastewater treatment system
- Service report requirements remain unchanged.

Scope of Work changes – Builders Licensing – Roof Work.

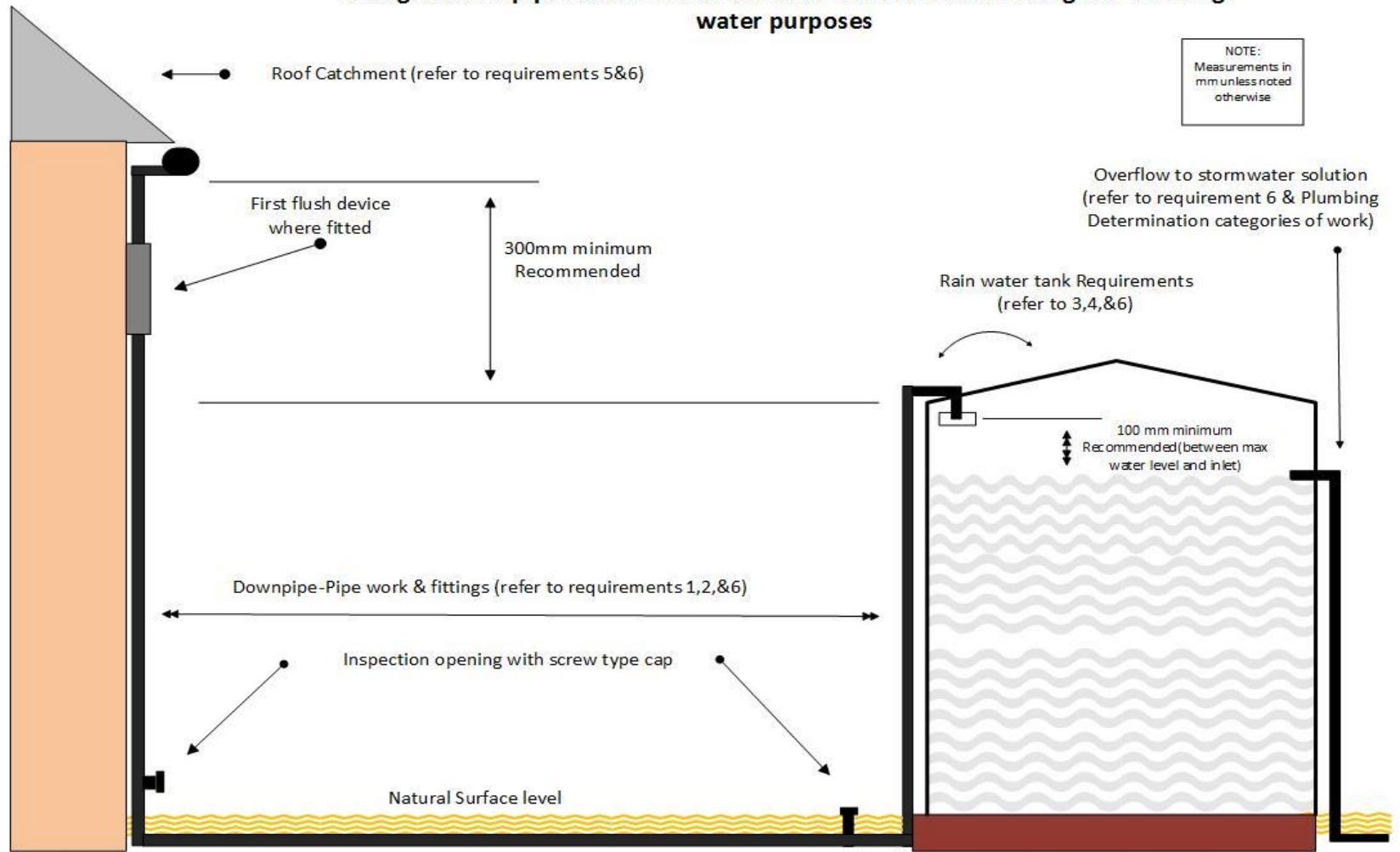

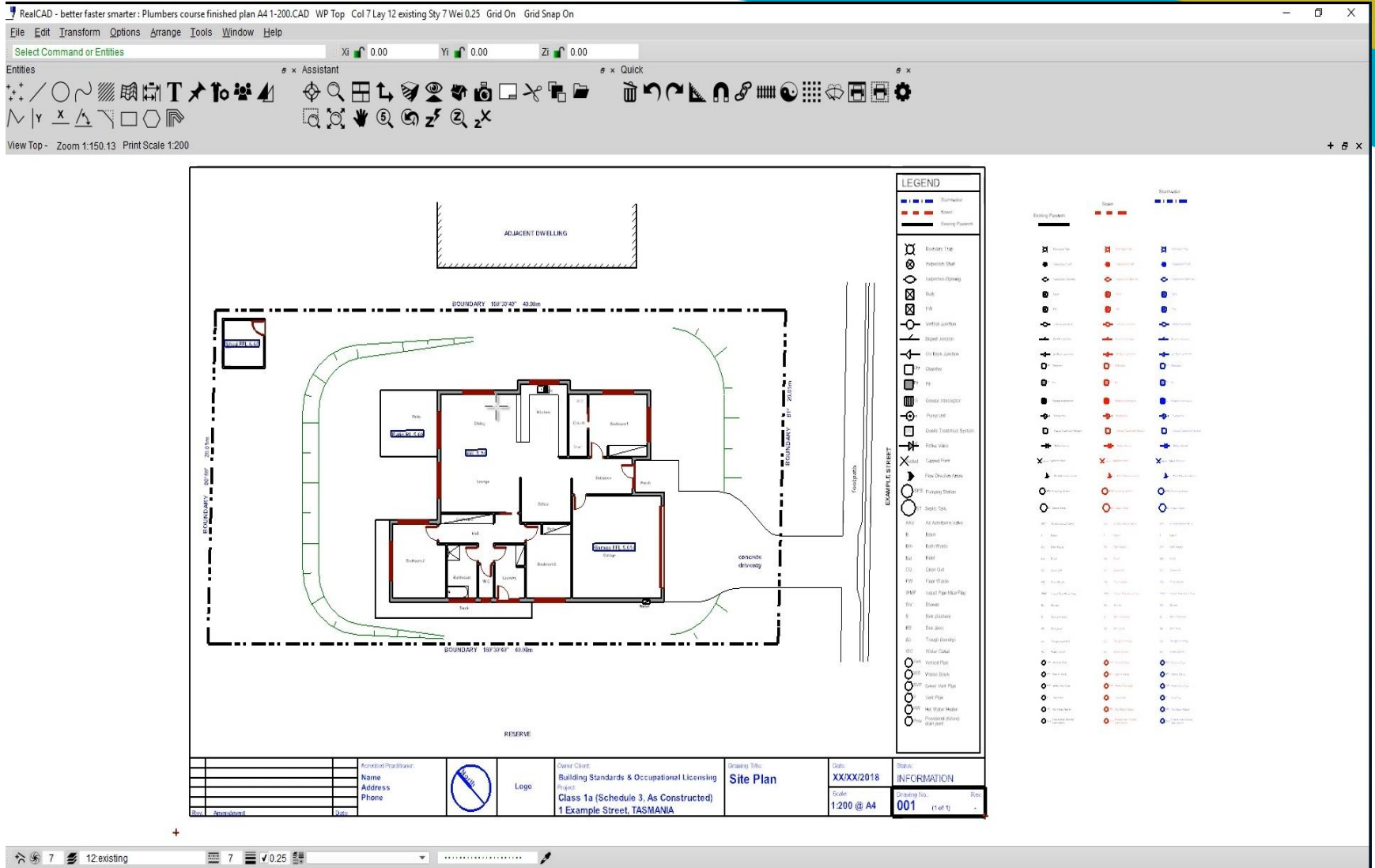
Directors Guidelines – PE Pipework – Sewer pressure applications.

- Details available on our web site.
- PE pipework for this application is to be cream or black with a cream coloured stripe
- Note: it is NOT permissible to use Lilac or purple coloured pipework for sewer effluent rising mains

Accredited Products – Fees now apply

- Mostly relevant to wastewater treatment system manufacturers and suppliers
- Other accredited products - \$763.14
- WWTS – \$1494.20
- Reminder for plumbers to make sure that they are only installing accredited products
