

Occupational Licensing (Eligibility to be a Plumber Nominated Manager) Determination 2011

Occupational Licensing Act 2005

8 August 2011

I, Kerrie Davidia Crowder, Administrator of Occupational Licensing, acting pursuant to sections 26 and 33(2)(b)(ii) of the *Occupational Licensing Act 2005* ("the Act") determine this day the eligibility requirements for a Plumber Nominated Manager.

1. Short title

This notice may be cited as the *Occupational Licensing (Eligibility to be a Plumber Nominated Manager) Determination 2011*.

2. Commencement

This Determination takes effect on 8 August 2011.

3. Purpose

This Determination revokes the *Occupational Licensing (Eligibility to be a Plumber Nominated Manager) Determination 2010* dated 15 December 2010 and establishes the eligibility requirements for nominated managers relevant to the management of a plumbing contractor's business that apply from 8 August 2011.

4. Application of Acts Interpretation Act 1931

The *Acts Interpretation Act 1931* applies to this Notification.

5. Eligibility – Plumber Nominated Manager

- (1) As at 15 December 2010, a person is qualified to be a nominated manager in respect of a plumbing contractor in the relevant class or classes of licence if -
 - (a) he or she was the holder of a current advanced registration in the relevant class of registration under the *Plumbers and Gas-fitters Registration Act 1951*; or
 - (b) the person can satisfy the Administrator that he or she has held the relevant class or classes of registration in the three years prior to receipt of the contractor's application.
- (2) Clause (1) expires on 15 December 2013.

Occupational Licensing (Eligibility to be a Plumber Nominated Manager) Determination 2011

- (3) As from 8 August 2011 a person is qualified to be a nominated manager in respect of a plumbing contractor if -
- (a) he or she is the holder of a -
 - (i) Plumber Practitioner (Certifier) Licence; **or**
 - (ii) Plumber Practitioner (Certifier Restricted) Licence –
- in the relevant class or classes of plumbing work undertaken under the contractor's licence.

(6) Revocation

The *Occupational Licensing (Eligibility to be a Plumber Nominated Manager) Determination 2010*, dated 15 December 2010, is revoked.
